Microsoft Teams Students should log in to the TEAMS room of the course through their institutional account. Their identification will be done using their institutional account. B. e-Class At the same time, they should log in to the e-class using their institutional account and go to the course page (a prerequisite must have registered for the course) (https://eclass.duth.gr/courses/OPE01142/) and in the section "EXERCISES" where they will be given the form of the examinations which they will fill in electronically. Each student will have to answer 25 multiple-choice questions. Each of the questions is scored 0.4. The duration of the exams will be 25 minutes. C.
